Nomination for election to the position of President or Vice Presidents shall be made on official Nomination Form. Candidate for those offices must be serving members of NEC. Nomination for election to be made by a Regional Congress. The Nomination must be seconded by a member of the Regional Committee. The Candidate must sign his/her acceptance of the nomination. The Chairman will authenticate the nomination. If Chairman is nominee, the Vice Chairman will authenticate the nomination.

Nomination for election to the position on NEC (other than that of President or Vice-Presidents) shall be made on official Nomination Form. Nomination for election to be made by Regional Congress. The Nomination must be seconded by a member of the Regional Committee. The Candidate must sign his/her acceptance of the nomination. The Chairperson will authenticate the nomination. If Chairman is nominee, the Vice Chairman will authenticate the nomination. Nominee for election to NEC must be a member of a Region Committee. A member may be nominated for not more than two positions on NEC in any one election. Completed original Nomination Form, must if being sent by post, be posted by registered post so that it should reach Secretary General not later than **31<sup>st</sup> January in year of election**. Proof of Postage Registration on a date allowing sufficient time for normal postal delivery of Nomination Form will be accepted as complying with this Schedule. (E-mail or Fax copy not accepted). Completed Original Nomination Forms may be handed to Secretary General not later than the **31<sup>st</sup> January in year of election**, on foot of Receipt of Delivery.
